

***2020 Ahava Dan Omaha Jewish Community Engagement Fund
Scholarship Application – Summer Camp***

The 2019 Ahava Dan Omaha Jewish Community Engagement Fund Scholarship has been EXTENDED to include 2020 Residential Overnight SUMMER CAMP!! The generous donors have allocated funds to be used for six awards of up to \$5,400 each. Any Jewish family in the Omaha metro area who has never sent a child to an overnight residential Jewish summer camp is eligible.

A few eligibility requirements and clarifications:

- The award is up to \$5,400 depending on the cost of the overnight residential Jewish summer camp.
- The award is available for children currently enrolled in grades 5 through 11.
- No child from the family has ever attended an overnight residential Jewish summer camp.
- The camp session must be for a minimum of three weeks.
- The summer residential Jewish camp must be recognized by the Jewish Federation of Omaha.
- The family must be a resident of the Omaha metropolitan area.
- At least one parent must be Jewish.
- Only **one** Ahava Dan award per family.
- The family must either be a member of a synagogue or the JCC or purchase a Gateway membership.

The completed application must be received by **February 17, 2020**.

The objective of the Ahava Dan Omaha Jewish Community Engagement Fund is to immediately impact the engagement of the Omaha Jewish Community by expanding access to meaningful Jewish experiences. We believe this new scholarship fund will serve as an incentive to engage families and their children. **Financial need is not a consideration in these awards.**

If more than six (6) families apply for the Ahava Dan Scholarship for Jewish residential summer camp, the Jewish Federation of Omaha will conduct a lottery and six lucky families will be selected.
