WITH COMPETENT AND CARING STAFF AND ATTENTION TO DETAIL, RBJH ENHANCES THE QUALITY AND CONTINUITY OF SENIOR LIFE IN OMAHA. RBJH HAS SERVED THE OMAHA JEWISH COMMUNITY AS WELL AS THE GREATER OMAHA COMMUNITY'S SKILLED NURSING NEEDS FOR MANY YEARS. THIS PAST YEAR RBJH TOUCHED THE LIVES OF 199 RESIDENTS, PROVIDING 33,888 DAYS OF SKILLED NURSING CARE TO BOTH SHORT-TERM AND LONG-TERM RESIDENTS.
